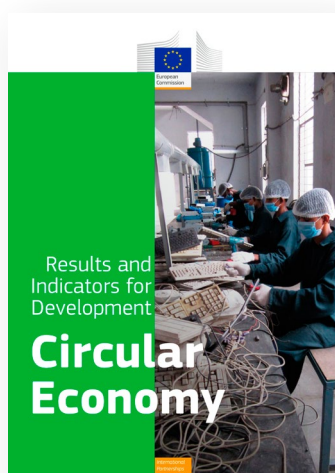


Supporting the Circular Economy

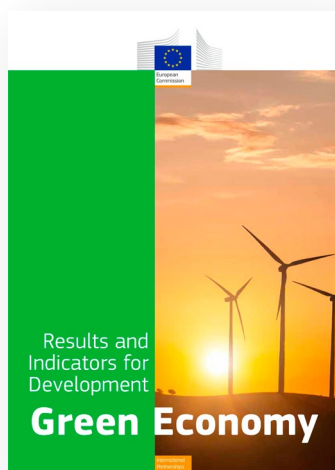
